

# Enjoy Indoor Riding Privileges

*Individuals renting stalls in the Tillamook County Fair barns will receive season riding permits entitling them the use of our 4H-FFA Pavilion during Open Riding times. For every one stalled animal, up to two individual season permits will be issued for the renter and an immediate family member. For every two stalled animals, the renter is eligible for a family season permit which will include the renter, an additional adult, and up to four of their children.*

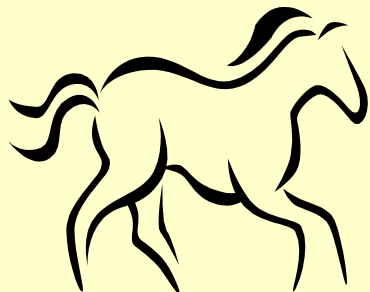
*Permits will be issued upon approval of rental application and completion of contract.*

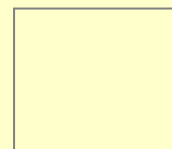

## Stable Rates

Stable Stalls	\$75.00 per month
Barn Stalls	\$100.00 per month
Tack Stalls	\$30.00 per month
Key Deposit	\$15.00 one time

First and last month's rent due at time of lease agreement.

A \$25.00 late fee will be assessed on all monthly payments not received in a timely manner and in the event of a returned check.

## Self-Care Facility

Stalls are checked daily and 24-hour emergency phone-numbers posted.

Owners must feed and care for animals on a daily basis.

Renters are responsible for ensuring stalls are cleaned and fresh bedding applied regularly.



## Tillamook County 4H-FFA Pavilion

In conjunction with the local 4H and FFA organizations, the Tillamook County Fair is proud to offer use of the new Pavilion as an indoor riding facility from October - June each year.

Individuals renting stalls on the fairgrounds will be given permits to use the Pavilion during Open Riding Times, and those individuals who stall elsewhere are also able to purchase, daily, monthly, or seasonal permits allowing them access to this amazing facility.
